June 3: Writing as a Form of Healing

As a newly bereaved parent Donna Rohrbaugh needed to know when if ever she might expect to experience some relief from the dark sadness and physical pain of her loss. She just needed to know that it would get better because she felt she certainly could not live for an extended period of time feeling as she did after burying her baby boy, James Ryan. Writing was always a form of relief for Donna, but after James Ryan there simply no words that could describe who she was or what she was feeling so she read the words others were able to write. When she was able to put pen to paper the depth of her words stunned her. Donna will talk to us about how writing can help in our grieving process.

July 1: Memorializing Our Children

Many bereaved parents seek ways to memorialize their deceased children and to keep their memories fresh in the minds of family, friends, and the community. Fran Palmer will demonstrate the making of garden stepping stones and lead a workshop for those interested in making the stones during the sharing group period of the evening.

LOSS OF A FOUNDING MEMBER OF BPUSA



Mitch Dudnikov died on Tuesday, April 27, with Reneé, the love of his life, his wife of almost 55 years, at his side. You may not have had the opportunity to know Mitch, but those who attended National Gatherings or who were active in the early days of our chapter certainly did.

Mitch and Reneé were founding members of BPUSA, and they helped support the establishment of our Anne Arundel County chapter 19 years ago. Mitch was a National Board member and a member of the Baltimore chapter. He and Reneé received the Roy & Juanita Peterson Award in 2001 for their endless and tireless work for BPUSA.

When their beloved son, Marc, died, his ashes were spread on top of a mountain in Washington state and Mitch's ashes will be spread in the same place. Reneé requests that each person who knew Mitch remember him in her or his own way, with a prayer or a thought of a special time spent with him. We mourn Mitch's death and our thoughts and prayers are with Reneé.



Stepping-Stone Making (July)

A reminder that for the *stepping stone making as a memorial*, bring the treasures that you would like to press into the stepping stones with you. Fran Palmer will try to bring some things with her. Her son Scott liked turtles and baseball, so there is a turtle and mini-baseball in his stone. Fran used those little beads with letters on them to spell out his name and used dominos for his birthdate.

We encourage you to use your imagination and also, bring rubber gloves. We will probably be making 8" round stones so bring nothing too big to use in that size stone.



CHANGES IN OUR LIVES

The death of a child brings many changes to our lives and lives of our families. The first change is death itself. Our child is dead-there is nothing we can do about that change. We mourn for this loss, saying "if only" and "why didn't we..." as we struggle with acceptance of the finality of death.

Then the changes in our daily life stand out. The extra place at the table, our child's room, their possessions, their clothes, and the phone calls and letters that are no more. Each one of us has experienced these agonizing and desperate changes, feeling helpless and frightened. Our anger and sense of unfairness over these changes can make our lives miserable, but we can do something about these changes.

Once you realize nothing or no one can bring you peace but yourself, you will begin to search for your personal peace.

A person who needs but refuses the painful physical therapy exercise to correct an injury will remain a cripple for life. The same is true of emotional therapy. We must do some things that are painful at first if our emotional state is to become stable again. If we avoid all situations that might be painful, we may end up as an emotional cripple. Our progress is slow and very painful but we can finally learn to use our grief in a positive way. Misery is optional - there is another way.

We have experienced not only death, but also life. Death has brought us closer to life and more aware of the living. This awareness of living makes us aware of the needs of others. Our compassion is expanded, our understanding of life is changed and given time, we reach out to others in their time of need. We cannot have coped with such a devastating loss and not be changed.

If I could have advertised the truck in our TCF Newsletter, the ad would have read: For sale (regretfully) '78 Toyota pickup truck, used by a college student when he was home for the weekends or semester breaks. Provided safe transportation through a snowstorm on his last New Year's Eve. Four speaker Craig stereo radio (brand name the same as the college driver's name) with rock music stations selected. Ash tray clean except for old bank receipts from his accounts. Truck used by father to haul things while thinking about his son. Price:

\$-Priceless, don't call.

It has been 18 months since my son died and yet it is still difficult to part with certain things-even things that did not belong to him. This is a problem which we're all faced with. What to keep? What to let go? The practical side of us says these things are no longer needed so we should get rid of them. The heart says my son or daughter owned these things or used these things; they bring back memories so we should keep them.

There is not a right or wrong answer as to what we keep or what we let go. I reassure myself by noting that these memories of my son didn't leave with that old yellow truck, but will remain locked in my heart forever.
