# WHAT'D I MISS LAST MONTH?

Thoughts & Summary by Carol Tomaszewski...

Every month we provide a program at our meeting that we hope will benefit many of us. But if you weren't at the meeting, then you don't reap this benefit. After some thought and discussion, I have decided to write a short summary of the previous month's program so that everyone who receives this newsletter will also receive a few thoughts from the programs every month. I hope this column will bring you some comfort, peace and hope along with the reassurance that we understand and are here to support you.

Holidays and Special Days, an interactive discussion with Carol Benjamin, included not only the traditional holidays but also the "sneaker" days. Following this summary is a 10 Steps list that Carol gave as a handout. One issue discussed was how others react to our grief and for instance, don't mention our children. Perhaps we need to give others "permission" to talk of our child since that would be the best gift we could receive. And assure friends and family that nothing they could say or do could make our grief any worse.

Plan ahead if you can. And if your plans include family and friends, then it may help to let them know your plans. Take care of yourself. It's important to do things that are meaningful to you. But be flexible with your plans and try to flow with the day.

Try to be ready for "sneaker" days & times. Those are the times when something triggers your grief and in a moment you can lose control. You can't really prepare and plan for these days because you can't be sure when they will happen. But don't be surprised when it happens because "sneakers" happen to all of us.

10 STEPS ON GETTING THROUGH THE HOLIDAYS Adapted from James Miller's Work

- 1. Accept the likelihood of your pain.
- 2. Feel whatever it is you feel. (acknowledgement).
- 3. Express your emotions (release work).
- 4. Plan ahead.
- 5. Take charge where you can.
- 6. Turn to others for support.
- 7. Be gentle with yourself.
- 8. Remember to Remember.
- 9. Search out and count your blessings
- 10. Do something for others.

I cherish all of my memories. I welcome them into my days and nights. They are all part of me and who I am.
