March 1: Using Music in Dealing with Grief

Some bereaved parents find music can be helpful in dealing with their grief. Paul Balasic will relate his experiences with music in his grief journey and talk about the role he believes music can play in the grief process. Members are urged to bring CDs or cassette tapes with music they have found particularly meaningful and helpful as they deal with their grief. We will use these as part of the discussion in some of our Sharing Groups.

MEETING TOPICS NOTE:

Each of our monthly meetings follow the same basic format. We first have a general session attended by everyone. During this first one-half hour we usually have a speaker or panel addressing a topic of interest and value to families mourning the death of a child. Following the general session, we break up into sharing groups. We always have the sharing groups, and the topics they discuss -- particularly for the newly bereaved groups -- do not necessarily focus on the program topic unless it is relevant to the members in the sharing group. We try to cover a range of topics in the programs we schedule, so that over the year we will have covered many topics which are of value to a broad range of members.

The Butterfly in Our Lives

Most often we hear, in our circles, of the butterfly representing the lives of our children who have died. Their spirit lives on and our memories live on, often in fleeting moments. But I think the butterfly's life cycle - metamorphosis - could just as easily represent our own lives. We seem to fit the four stages of that cycle.

THE EGG: when we are small, we are protected, changing, and living in a somewhat small and safe world - much like the butterfly egg attached to a leaf somewhere.

THE CATERPILLAR: the caterpillar is much like our lives before the death of our child or children. We go through the day doing what we need to do. We grow a lot and we change somewhat slowly. We devour many things in daily life - work, church, Little League. And then the child is gone. We change!

THE COCOON: after the death of our child, we shut ourselves off from so much because of our grief. We often encase ourselves in the blanket of grief and depression that is what protects us from the horrible pain. We don't want to be a part of life because of all the painful memories. There are reminders out there which cause pain.

THE BUTTERFLY: the pain lessens and we begin to heal as we work through the grief process, and we begin to see a ray of light - a little color. Some of the weight is removed. We break open our cocoon and begin to reach out ever so slightly and touch life again, just to see if it will hurt too much. As we discover the brighter days and brilliant colors of life, we become more like the butterfly. We are free to once again be a part of life and we can move about more easily and begin to take some of the nectar from life.



SOME PEOPLE SAY

"I wouldn't go to one of those grief meetings. It's morbid – people sitting around talking about the dead." How wrong those people are.

In so many ways, those who attend are saying, "I am hurting now, but I want to go on with my life." They are saying, "I am crying now, but I want to laugh again." They are saying, "I am sick in body and soul, help me get well." I see these things as healthy, not morbid.

It is not easy to walk into a meeting of any kind alone, especially one where the subject is very emotional, but once there it takes only a few minutes to find out we are not alone, that there are those who care about us and want to help us. We see others hurting and suddenly we want to help them. I don't see that as morbid.

A grieving parent wants to talk about his beloved child who is no longer physically part of his life. That child has died with a tragic suddenness or as a result of an illness that usually takes older people. We want to know why or find a reason or some meaning in our child's death. I don't see any morbidity in trying to understand.

Memories of our child are all we have left. We have a driving need to hang on to those memories lest we lose that small bit of our child. It is not morbid to want to keep that small part alive forever, at least in our hearts and minds.

To walk into a support group meeting is a loud shout – "I want to live and be happy again." It is a cry that "My child is dead, but I know he would want me to go on and be a better person for the suffering." It is a confirmation that even though part of life is gone, there is a reason to go on. There is nothing morbid about doing what is necessary in order to re-enter the mainstream of life.
